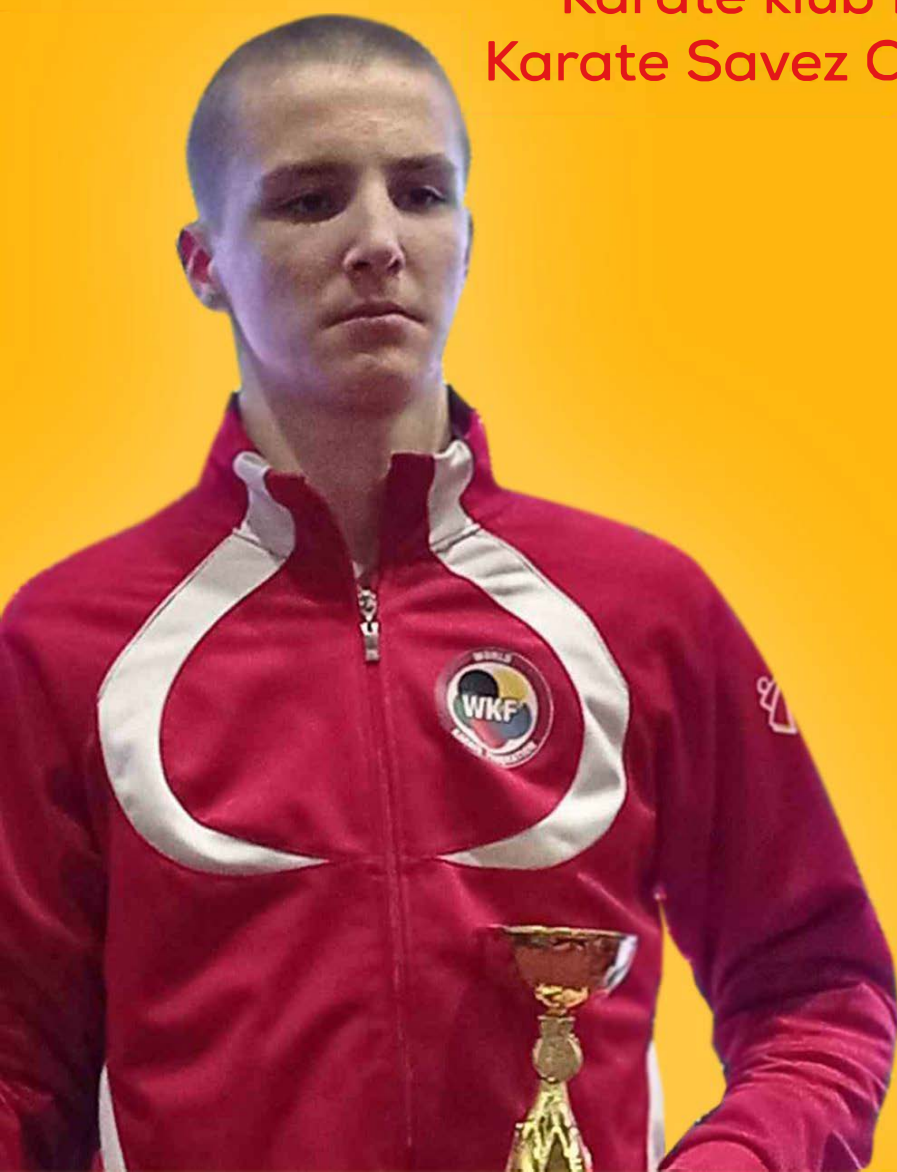

- Bunkai are doing cadets-juniors.
